### Dear Parents/Carers/Friends, Positive Start

The start to the year has gone extremely smoothly for most classes. At this time of the year, we put a priority on staff getting to know their students and working out their preferences and any particular dislikes or sensory issues that they have. This is where parents come to the fore as they know their child better than anyone which is why we are looking to complete Student Support Group (SSG) meetings next week. This will give staff the opportunity to discuss early positives or start to solve any issues with parents as soon as we can.

#### Student Support Group (SSG) Meetings

All staff are contacting parents to arrange for a formal student support group meeting. These meetings are a requirement for all of our students and need to occur at least twice per year. Parents are asked to bring along any ideas that they have for their child's learning program and to consider priorities that they have for their student both in the short and long term. Once completed a written account of the SSG meetings will be sent home for all parents to keep and monitor across the course of the year.

#### **Diaries**

All students will be bringing home a student diary on a daily basis and this will be the primary form of communication with parents each day. Parents are asked to check the diaries each day, read any comments that staff make in the diary and use it to let staff know of any issues or upcoming events in the child's life. Parents can also call the school if they have any queries about the day and staff will always contact parents by phone if there was a significant issue that they need to be aware of.

#### Hats, Caps and Sunscreen

As a sun smart school all students are required to wear a hat whilst they are in the yard at recess and lunchtime as well as while they are on outings. Unfortunately, sun smart hats do not include caps. Many of our students are wearing caps to and from school and while this is fine, all students must have a broad brimmed hat or bucket hat to wear during the day. All classrooms have sunscreen in them, and

teachers and ES staff will apply sunscreen to students during this sunny period of the year. There are a number of students that have allergies to sunscreens. If your child has such an allergy, please let your child's teacher know and if possible, supply a sunscreen that they can use each day. All staff are particularly aware of the sun at this time of the year, and we will do everything that we can to ensure students remain as sun smart as possible.

#### **School Council News**

Our first school council meeting for the year will be held next Wednesday 14<sup>th</sup> February at 6:00pm in the staffroom. Interested parents are invited to attend the meeting, as we will be calling for member nominations over the following weeks.

Meetings are usually held twice a term. They are held on Wednesday evening from 6:00 – 8:00pm. An additional meeting is held in term 4 to set and accept the school's budget for the following year.

If any parents are interested in being a part of the school council, please feel free to come in and ask about what is involved. The Annual Reporting Meeting (AGM) of the school council will be held on Wednesday 20th March at 6.00pm. We are now calling for nominations for the school council.

An information flyer on school council and nomination forms are included in this newsletter. Additional nomination forms are available from the school office. Staff and parents can nominate themselves for the election, or someone else can nominate them. Nominations for School Council will close on Friday the 8th of March, 2024.

# ROOM 3 NEWS Michelle, Amelia, Tulashi & Julie




Room 3 are settling in to school routine, and are enjoying getting to know each other.

We are doing lots of fun activities to practice learning our school expectations of Follow Instructions, Be Respectful and Be Safe.


We are also enjoying our Specialist classes and excited to go to the Life Skills House each week.






























#### **SCHOOL POLICIES**

#### UNIFORM AND APPEARANCE

School's compulsory school uniform items are as follows:

#### Junior and Middle year students' uniform

Navy shorts (knee length or just above)

Navy track pants in Term 2 and 3 and cooler weather.

Burgundy polo shirt with collar.

Burgundy windcheater or button front fleecy jacket available from uniform shop.

A checked dress, with bike shorts beneath, which is the same across the school.

Broad-brimmed navy sunhat for Term 1 and 4.

Black leather school shoes or supportive pair of runners. Sandals with an enclosed heel and toe may be worn in hot weather.

#### **Senior Students:**

Navy shorts (knee length or just above knee) or knee length navy skirt if preferred.

Navy track pants or trousers in Term 2 and 3 and cooler weather.

Navy polo shirt with collar.

Navy jumper.

Broad-brimmed navy sunhat for Term 1 and 4.

#### ATTENDANCE POLICY

Schooling is compulsory for children and young people aged from 6 to 17 years (unless an exemption from attendance or enrolment has been granted).

Daily attendance is important for all children and young people to succeed in education and to ensure they do not fall behind both socially and developmentally. School participation maximises life opportunities for children and young people by providing them with education and support networks. School helps people to develop important skills, knowledge and values that set them up for further learning and participation in their community.

## Students are expected to attend Belvoir Special School during normal school hours every day of each term unless:

- there is an approved exemption from school attendance for the student.
- the student has a dual enrolment with another school and has only a partial enrolment in Belvoir Special School, or
- the student is registered for home schooling and has only a partial enrolment in Belvoir Special School for particular activities.

Both schools and parents have an important role to play in supporting students to attend school every day.

Belvoir Special School believes all students should attend school all day, every day when the school is open for instruction and is committed to working with its school community to encourage and support full school attendance.

#### PERSONAL PROPERTY

REMINDER – the Department (which includes our school) does not have accident insurance. Items of personal property that are lost, stolen or damaged at school are not the responsibility of Belvoir Special School or the Department. Staff and students are reminded not to bring items of value to school.



## Life Skills NEWS

#### Anthea



Lessons have started in the Industrial Kitchen for Food Tech and in the Life Skills House for Life Skills. Students have been extremely excited to be working in both of these spaces.

Over the past 2 weeks Yellow Pod students in the Industrial Kitchen have made playdough and toasted sandwiches. In the Life Skills House students have been focussing on learning to wash and dry dishes. One student told me this week that they couldn't practice at home "cos Grandma wouldn't let me wash her plates". I did explain that sometimes we have precious things that we need to be careful of. Next week students will be making scones and in the house the focus will move to learning to make a bed and clean the toilet.

Green Pod students began these lessons this week (Mondays). In the Kitchen they made playdough. In the Life Skills house they are also focusing on learning to wash and dry dishes. Green Pod next week in the kitchen will also make scones, but continue with another week of washing and drying dishes before moving to learning to clean windows (external), sweep pathways and weed the garden.

Purple and Orange Pods last week made Apple and Cinnamon Scrolls. These were a huge hit with Staff Café last year, and were again a hit with the secondary students who have asked for a copy of the recipe to take home and make again. Secondary Students will be making Devilled Sausages and mashed potatoes this week. Next week they will make Giant Chocolate Chip Cookies.

In the Life Skills House Purple Pod are focusing on setting the table, clearing the table, loading and unloading the dishwasher and wiping the dining table clean. Next week their learning will move to hanging and folding washing. Orange Pod are learning to fold sheets, and I must say they are doing a mighty fine job at folding those pesky fitted sheets – they need to refold my linen press for me. Next week they will move their learning to setting the table, clearing the table, loading and unloading the dishwasher and wiping the dining table clean.

Orange Pod students are also back in the kitchen preparing treats for staff with the Staff Café – on the menu this week is Caramel Slice and Finger Lime Cake.

Please if you have the opportunity to continue practicing these skills at home with your children it would be great to assist them to transfer their learning to memory.

#### Camps, Sports and Excursions fund eligibility

Below are the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

#### Criteria 1 - Eligibility

To be eligible\* for the fund, a mature minor of sixteen years of age or over, a parent or legal guardian of a student attending a registered Government or non-government Victorian primary or secondary school must:

- · on the first day of Term one, or;
- · on the first day of Term two.
- a) Be an eligible beneficiary within the meaning of the State Concessions Act 2004, that is, be a holder of Veterans Affairs Gold Card or be an eligible Centrelink Health Care Card (HCC) or Pensioner Concession Card (PCC) holder, OR
- b) Be a temporary foster parent, and;
- c) Submit an application to the school by the due date.
- \* A special consideration eligibility category also exists. For more information, see: Camps, Sports and Excursions Fund (CSEF): Eligibility | education.vic.gov.au

Mature minors or parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

#### Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and seventeen years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and eighteen years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooling, or TAFE.

#### **Eligibility Date**

For concession card holders, CSEF eligibility will be subject to the parent/legal guardian's concession card being successfully validated with Centrelink on 29 January 2024 and/or 15 April 2024.

#### Payment amounts

#### **CSEF** payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- · Primary school student rate: \$150.00 per year.
- · Secondary school student rate: \$250.00 per year.

The CSEF is paid directly the school and will be allocated by the school towards camps, sports and/or excursion costs for your child.

For ungraded students, the rate payable is determined by the student's date of birth. **Foundation and Year 7 government school students** who are CSEF recipients are also eligible for a uniform voucher. Schools are required to make applications on behalf of parents, so please register your interest at the school.

#### How to complete the application form

#### NOTE: ALL SECTIONS MUST BE COMPLETED BY PARENT/LEGAL GUARDIAN

- Complete the PARENT/LEGAL GUARDIAN DETAILS section.
   Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.
  - If you are claiming as a Foster Parent or a Veteran Affairs Pensioner, you will need to provide a copy of documentation confirming your status as a temporary Foster Parent or provide your Veterans Affairs Pensioner Gold card to the school.
- 2. Complete the STUDENT/S DETAILS section for students at this school.
- Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2024 closes at the end of term two 2024.

CSEF payments cannot be claimed retrospectively for prior years.

#### Camps, Sports and Excursions fund eligibility

Below are the criteria used to determine a student's eligibility for the Camps, Sports and Excursions Fund (CSEF).

#### Criteria 1 - Eligibility

  - c) Submit an application to the school by the due date.

Mature minors or parents who receive a Carer Allowance on behalf of a child, or any other benefit or allowance not income tested by Centrelink, are not eligible for the CSEF unless they also comply with one of (a) or (b) above.

#### Criteria 2 - Be of school age and attend school in Victoria

School is compulsory for all Victorian children aged between six and seventeen years of age inclusive.

For the purposes of CSEF, students may be eligible for assistance if they attend a Victorian registered primary or secondary school. Typically, these students are aged between five and eighteen years inclusive.

CSEF is not payable to students attending pre-school, kindergarten, home schooling, or TAFE.

#### **Eligibility Date**

For concession card holders, CSEF eligibility will be subject to their concession card being successfully validated with Centrelink on 29 January 2024 and / or 15 April 2024.

#### Payment amounts

#### CSEF payment amount

The CSEF is an annual payment to the school to be used towards camps, sports and/or excursion expenses for the benefit of the eligible student.

- Primary school student rate: \$150.00 per year.
- Secondary school student rate: \$250.00 per year.

The CSEF is paid directly to the school and will be allocated by the school towards camps, sports and/or excursion costs for the child.

For ungraded students, the rate payable is determined by the student's date of birth. For more information, see: <u>Camps, Sports and Excursions Fund (CSEF): Payment amounts | education.vic.gov.au</u>

**Foundation and year 7 government school students** who are CSEF recipients are also eligible for a uniform voucher. Schools are required to make applications on behalf of parents, so please register your interest at the school.

#### How to complete the application form

#### NOTE: ALL SECTIONS MUST BE COMPLETED BY A MATURE STUDENT, SIXTEEN YEARS OR OVER

- 1. Complete the Applicant DETAILS sections.
- 2. Make sure that the Surname, First Name, and Customer Reference Number (CRN) details match those on your concession card. You will also need to provide your concession card to the school.
- 3. Sign and date the form and return it to the school office as soon as possible. The CSEF program for 2024 closes at the end of term two 2024.

CSEF payments cannot be claimed retrospectively for prior years.

#### Fact sheet 1: school council elections – information for parents

#### What is a school council and what does it do?

All government schools in Victoria have a school council. They are legally constituted bodies that are given powers to set the broad direction of a school, in accordance with Ministerial Order 1280 Constitution of Government School Councils, and the *Education and Training Reform Act 2006*. In doing this, a school council may directly influence the quality of education for students.

#### Who is on the school council?

For most primary school councils, there are several possible categories of membership:

- A mandated elected parent member category —members of this category generally comprise more than one third of the council's total membership. Department employees can be parent members at their child's school providing that they are not engaged in work at the school.
- A mandated elected school employee member category members of this category make up no more than one-third of membership. The principal of the school is automatically one of these members.
- **An optional community member category** members are co-opted by a decision of the council because of their special skills, interests or experience. Department employees are not eligible to be community members.

A small number of school councils have nominee members.

For all schools with a Year 7 and above cohort, there is an additional category of membership:

#### A mandated elected student member category, two positions.

Generally, the term of office for all members is two years. The term of office of half the members expires each year, creating vacancies for the annual school council elections.

#### Why is parent membership so important?

Parents on school councils provide important viewpoints and have valuable skills and a range of experiences and knowledge that can help inform and shape the direction of the school.

Those parents who become active on a school council find their involvement satisfying and may also find that their children feel a greater sense of belonging.

#### Do I need special experience to be on school council?

Each member brings their own valuable skills and knowledge to the role, however, in order to successfully perform their duties, councillors may need to gain some new skills and knowledge.

It is important to have an interest in your child's school and the desire to work in partnership with others to help shape the school's future.

#### Code of conduct for school councillors

School councils in Victoria are public entities as defined by the *Public Administration Act 2004*.

School councillors must comply with the Code of Conduct for Directors of Victorian Public Entities issued by the Victorian Public Sector Commission. The Code of Conduct is based on the Victorian public sector values and requires councillors to:

- **act with honesty and integrity** be truthful, open and clear about their motives and declare any real, potential or perceived conflict of interest and duty
- act in good faith in the best interests of the school work cooperatively with other councillors and the school community, be reasonable, and make all decisions with the best interests of students foremost in their minds

act fairly and impartially – consider all relevant facts of an issue before making a decision, seek to have a balanced view, never give special treatment to a person or group and never act from self-interest

**use information appropriately** – respect confidentiality and use information for the purpose for which it was made available

 $\textbf{exercise due care, diligence and skill} - accept responsibility for decisions and do what is best for the school \\ \textbf{use the position appropriately -} not use the position as a councillor to gain an advantage$ 

act in a financially responsible manner – observe all the above principles when making financial decisions comply with relevant legislation and policies – know what legislation and policies are relevant for which decisions and obey the law

**demonstrate leadership and stewardship** – set a good example, encourage a culture of accountability, manage risks effectively, exercise care and responsibility to keep the school strong and sustainable.

#### Indemnity for school council members

School councillors are indemnified against any liability in respect of any loss or damage suffered by the council or any other person in respect of anything necessarily or reasonably done, or omitted to be done by the councillor in good faith in:

the exercise of a power or the performance of a function of a councillor, or

the reasonable belief that the act or omission was in the exercise of a power or the performance of a function of a council.

In other words, school councillors are not legally liable for any loss or damage suffered by council or others as a result of reasonable actions taken in good faith.

#### How can you become involved?

By participating in, and voting in the school council elections, which are held in Term 1 each year. However, ballots are only held if more people nominate as candidates than there are positions vacant.

In view of this, you might consider:

standing for election as a member of the school council encouraging another person to stand for election.

#### What do you need to do to stand for election?

The principal will issue a Notice of Election and Call for Nominations in Term 1 of each year. Council elections must be completed by 31 March, unless varied by the Minister for Education.

If you stand for election, you can arrange for someone to nominate you as a candidate or, you can nominate yourself in the parent member category. You can only be nominated by another member of the same category that you are eligible for (e.g. a member of the parent electorate may only nominate another parent of that electorate).

Department employees with a child enrolled at a school where they are not engaged in work, are eligible to nominate for parent membership at that school.

Return your completed nomination form to the principal within the time stated on the Notice of Election. You will receive a Nomination Form Receipt via post, email or by hand delivery.

Generally, if there are more nominations than vacancies a ballot will be conducted in the two weeks after the call for nominations has closed.

#### Remember

Consider standing for election to school council.

Ask the principal for instructions if you are not sure what to do.

Be sure to vote if the election goes to ballot.

Contact the principal if you are unsure about what is required at any stage of the election process.


